## **Town Rezoning Update - Christopher Bogdan**

The ROCC BOD engaged their attorney to advise and represent the Association regarding a proposed development planned for an area on Smith and Transit Roads. The plan includes mixed use commercial and residential buildings. Most importantly and imminent was a connection to Ransom Oaks Community through Ruby Lane, currently a dead end street.

Areas of concern:

- Connection to Ruby Lane allowing for increased traffic through the neighborhood
- Traffic increase on Smith and Transit Roads.
- Drainage and flooding implications and runoff into Black Creek.
- Zoning CTTR-5, 5 story buildings developed in backyards of RO properties.
