Finances

For Discussion

- BOD reviewed budget, projects, operating expenses and reserve study.
- Possible project for next year: spending \$3875 to replace missing sidewalk spaces along Old Oak Post. Approval would be necessary from residents where the gaps occur on their property.
- Approximately \$7000 to replace concrete slabs on pool deck and patch all spots at RO and GW.
- GW clubhouse flooring replacement can wait, but shoe mold replace should be inexpensive upgrade.

Architectural Hearing: Fences

- New residents at 55 Kingsbrook 6:30pm residents replaced a lattice fencing piece but doubled its size and replaced it with solid panel privacy fence. Architectural Committee denied request for fence. Application submitted post installation. Residents made case to keep fence for privacy and safety.
- New residents at 47 Kingsbrook 7:00pm Fence was in place at the time of the walk through prior to the closing in 2019. Property was under Fannie Mae ownership and Fannie Mae brought this property in to the HOA prior to current resident closing. Prior

alleged fence was removed before this resident closed. Fence removal was not directed by HOA. The resident asked that his new privacy panel fence be grandfathered in due to outlined circumstances.
