## Ransom Oaks Proxy & Ballot

Again this year we will continue the random drawing we initiated in 2005. A single proxy/ ballot will be drawn and the winner will have their 2017 annual assessment waived (amount not to exceed the amount of the 2017 assessment). All valid proxy/ballots received prior to the start of the Annual General Meeting (AGM) will be eligible. Members of the ROCC Board of Directors are not eligible for this drawing.

If you are a property owner in Ransom Oaks, have paid all assessments and have no outstanding liens against your property you can cast your vote in one of two ways:

1. Attend the AGM with proper identification and deposit the enclosed Ballot (or one provided at the meeting) in the Ballot box.

2. Vote by Proxy: Complete the enclosed Proxy form, either assigned to someone or left to the recording secretary.

Vote for the candidate(s) of your choice or leave the Ballot blank. Separate the Proxy from the Ballot and fold over and staple the Ballot for privacy.

Place both in the same sealed envelope and either give it to your assignee or mail to:

### Ransom Oaks Board Meeting Highlights

December 12, 2016

- One resident attended the meeting. The residents whose properties are in the Wetlands buffer zone are seeking help from the New York State legislature.
- There are only **two candidates** running for the three open seats in the January election.
- All residents should have received their ballots in the mail. They can be mailed in or deposited in the ballot box at the Annual General Meeting, January 9th at 6:30 PM at the Greenwoods meeting room.
- We expect to be about \$14,000
   over budget at the end of
   2016. We completed capital
   improvements in 2016 that
   were budgeted in 2015. At the
   end of 2015 those funds were
   moved to the reserve fund
   and then withdrawn this year.
   Also, we paid a deposit for the
   resurfacing of the Ransom Oaks
   pool, budgeted in 2017.
- The property that was seized by the U.S. Marshal Service did not complete the sale yet so a lien was filed for non-payment of assessments.
- PayPal will be available to pay the 2017 assessments. Only 30 or so residents paid using PayPal last year. PayPal payments are a burden during the audit. With such low utilization we are considering suspending PayPal for future assessments.
- Bids for landscaping from four companies were reviewed. All Seasons, the current contractor, was selected.
- We will attempt to **repair the Eveningwood pavilion** before pool season.
- We use Nature's Lawn Liquid Natural Aeration on our playground areas.


## 2017 Amherst Resident ID Cards

Resident photo ID cards for the 2017 calendar year will be sold starting Monday, December 12.

A valid ID card is needed to register for programs, to receive resident discounts for open skate as well as unlimited use of the Clearfield and North Forest pools during summer months.

Proof of residency and a new photo (taken at registration) are required. Cards may only be purchased at the Northtown Center at Amherst. The office will be open the following Sundays from 10am-2pm for card purchase only: January 22, January 29, February 5 and February 12, 2017.


## Curbside Metal Pickup
